I shall forward your inquiry to him and ask that he write you direct in order to save time.

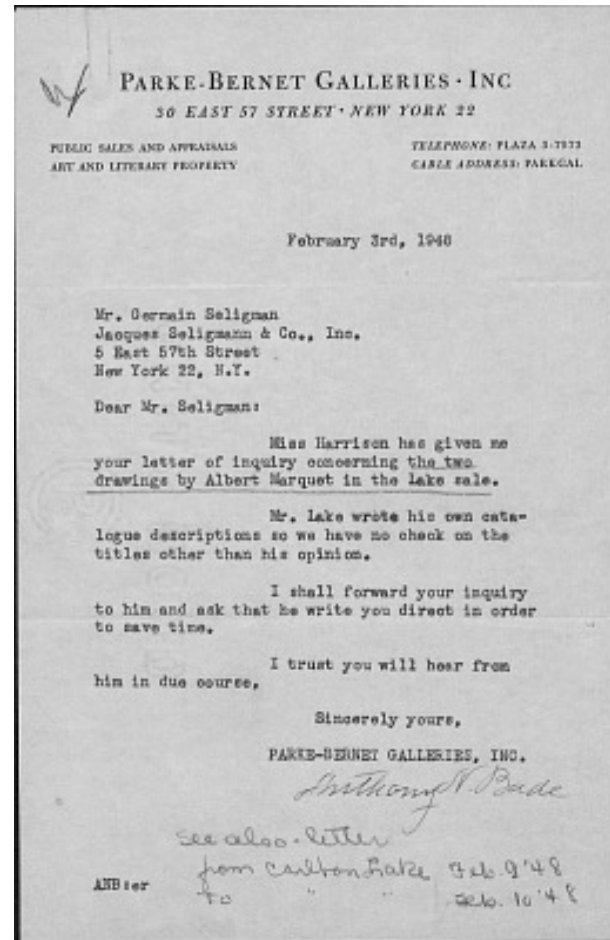
