In answer to your letter dated Nov 22nd 1867. making inquiry about property returned to the heirs of Esther Meekins October, 1866, at Roanoke Island NC, I have the honor to state J. C. Meekins (on as called on Roanoke Island, Chauncey Meekins) did not have other property occupied by the Gov'm't except~ that which belonged to the family, which amounts to 225 acres more or less, and was returned to him in obedience to enclosed order. I have reported on my land return, such facts, the same month, of which I have the honor to enclose the duplicate copy.


