

Franklin Co. Sept 25, 1865. This agreement, entered into this 25th day of Sept 1865- Between Jno R. Moss of the 1st part & Isaac Young (col'd) of the 2nd part- Witnesseth that the said Jno R. Moss has sold the farm he now has on to Isaac Young, the conditions of which sale, are as follows. Peice of land (\$650) Six hundred & fifty Dollars. Four hundred dollars to be paid by the 1st day of Dec next the balance to be paid twelve months from the 1st day of Dec next.. date of 1st pay^{mt}.

The said Jno R. Moss to pass the title on 1st day of Dec The said Isaac Young to give note & good security for balance. viz Two hundred & fifty Dollars. And the said Jno R. Moss, warrants & defends the title. The said Jno R. Moss, acknowledges the receipt of one dollar in gold, in confirmation of this contract.
