No 159.

I A board of Officers is hereby appointed to meet at New Berne N.C. on
the 2nd day of January 1867, or as soon thereafter as practicable for the
purpose of considering the question of rent, of certain property,
belonging to Mr. G.W. Street and used for Hospital purposes at New
Berne N.C. in compliance with instructions contained in Circular No. 6
War Dept. Bureau R.F. and A.L. Office Chief Qr Mr.

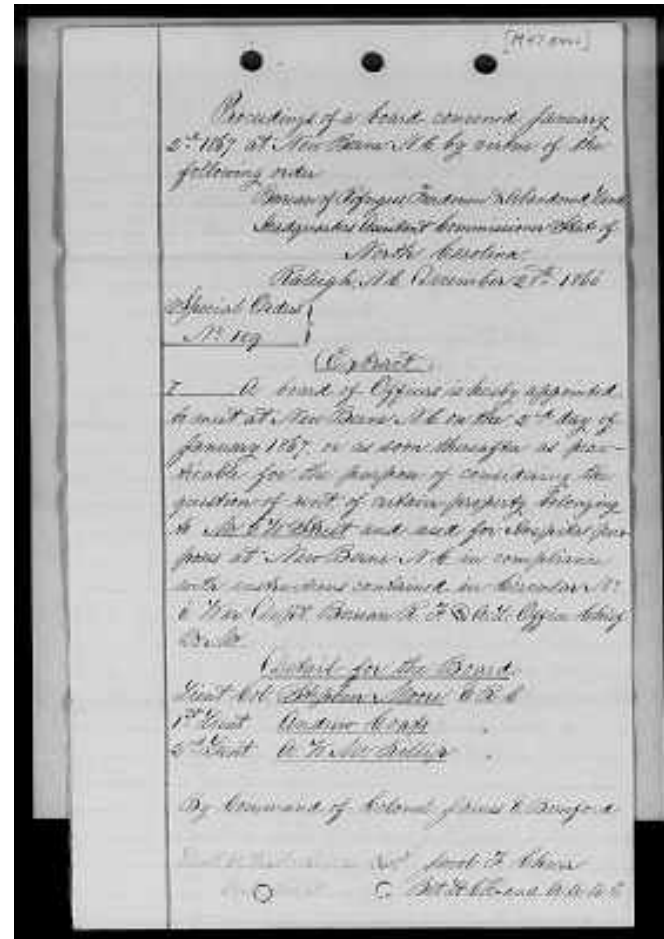
