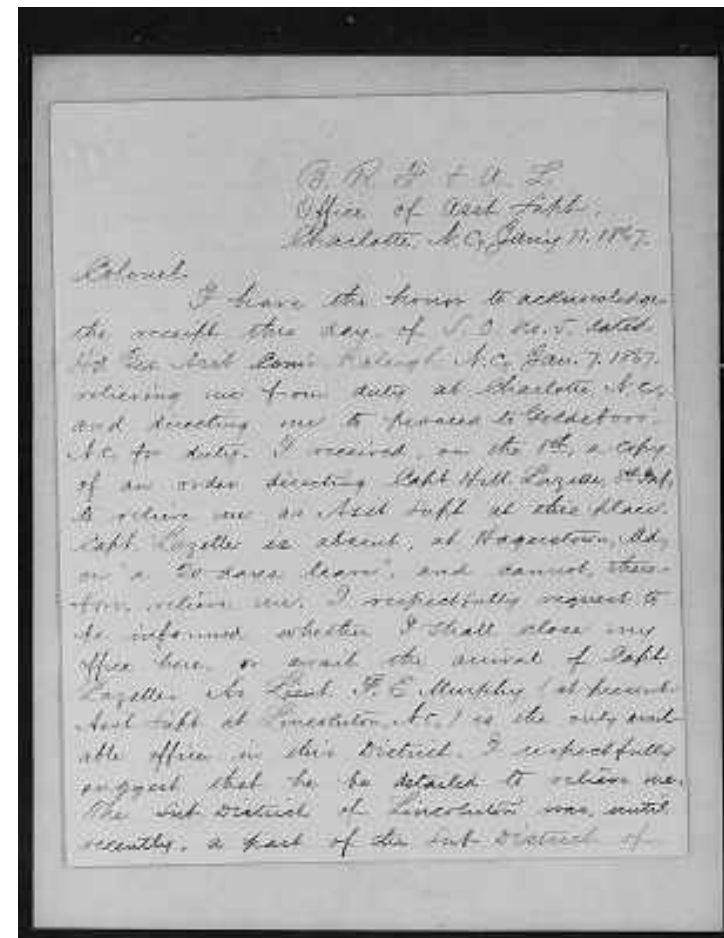

Colonel,

I have the honor to acknowledge the receipt, this day, of S.O. No. 5, dated Hd Qs. Asst Com'r, Raleigh, N.C., Jan. 7. 1867, relieving me from duty at Charlotte, N.C., and directing me to proceed to Goldsboro, N.C. for duty. I received, on the 8th, a copy of an order directing Capt. H.M. Lazelle, 8th Inf., to relieve me as Asst Sup't at this place. Capt. Lazelle is absent, at Hagerstown, Md., on "a 20 days leave", and cannot, therefore, relieve me. I respectfully request to be informed whether I shall close my office here, or await the arrival of Capt. Lazelle. As Lieut. P.E. Murphy (at present Ass't Sup't at Lincolnton, N.C.) is the only available officer in this District, I respectfully suggest that he be detailed to relieve me. The Sub-District of Lincolnton was until recently, a part of the Sub-District of
