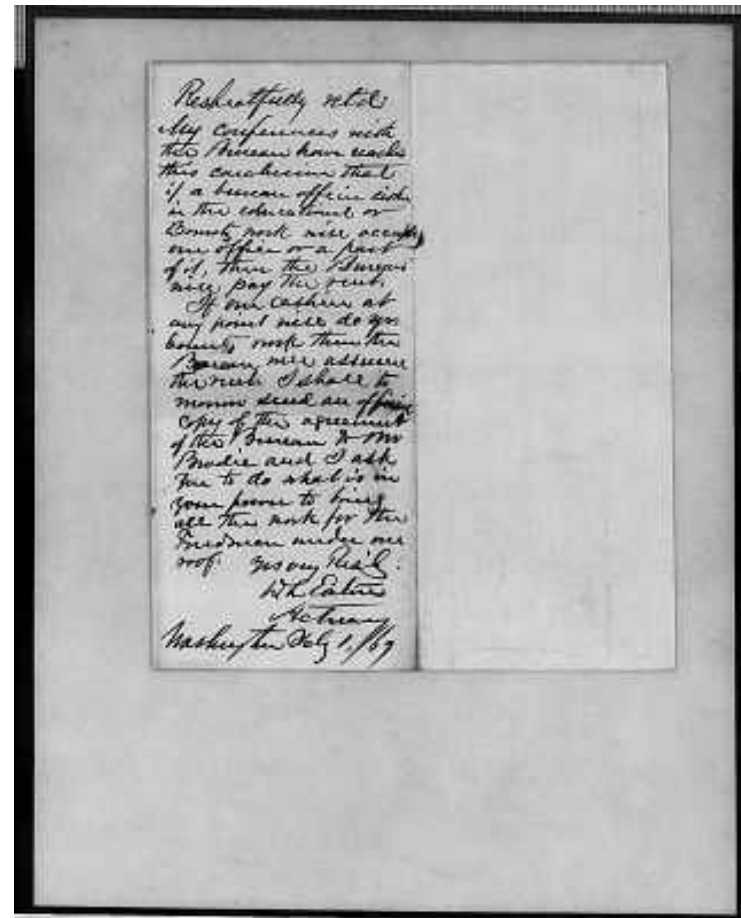
Respectfully ret'd
