Inquires whether in transfer of buildings for school purposes to Board of Trustees, there is any objection to one or more (not exceeding a minority) of the Board being white persons

Recommends that in such cases as school erected at Raleigh for Miss [Martha Mason] and the one at High Shoals for Mrs [Admiral Wilkes], a white person may represent the interest of those who have hitherto been interested in the welfare of the freedmen, &c &c

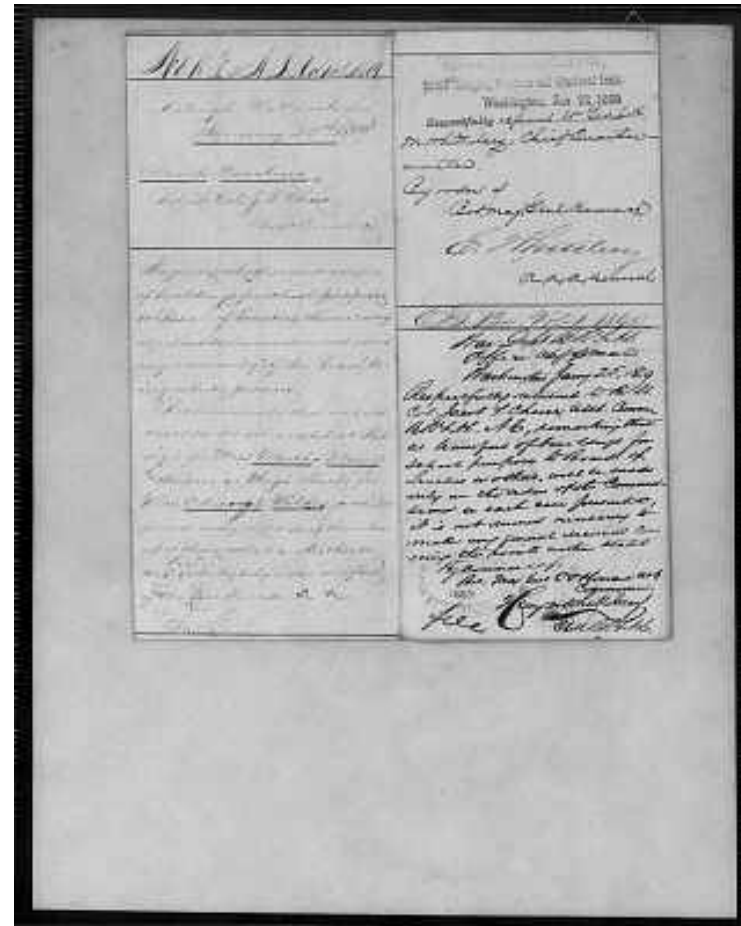




