20th.



Nothing to do this afternoon, so I went out to the "Prinzessin" to get a hair-cut. Last time I was on board her was when Vining left her. Strange, but I got my first letter from him, by her.

Speaking of "strange" reminds me of that story of the lawyer named Strange. When he died, they had a tombstone put over the grave with the bare words "Here lies an honest lawyer." And of course, everybody who read it said "That's strange!"
