It is hereby agreed between Messrs. Arnold, Cheney & Co. of New York, N. Y. on the first part ; and Mr. Ernst R. Domansky, Jr. of No. Castine, Me. on the second part as follows :

The said Ernst R. Domansky, Jr'. agrees to enter the employ of the said Arnold, Cheney & Co. as Assistant to Agent, or as Agent at any of their Agencies now existing, or that may be established, for a period of three 3 years.

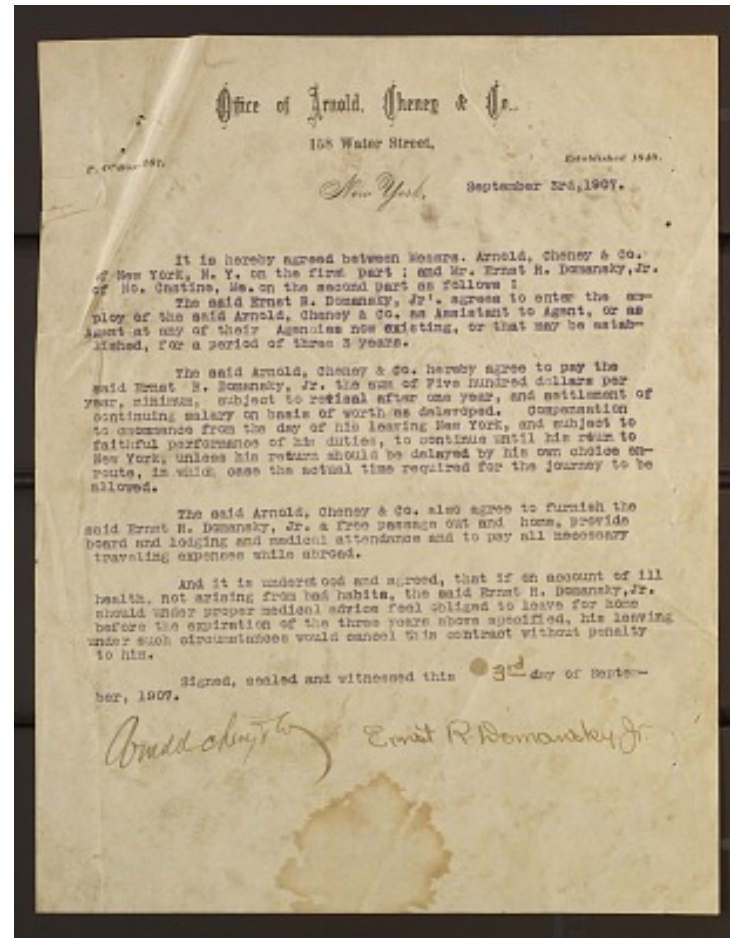
The said Arnold, Cheney & Co. hereby agree to pay the said Ernst R. Domansky, Jr. the sum of Five hundred dollars per year, minimum, subject to revival after one year, and settlement of continuing salary on basis of worth as developed. Compensation to commence [[commence]] from the day of his leaving New York, and subject to faithful performance of his duties, to continue until his return to New York, unless his return should be delayed by his own choice enroute, in which case the actual time required for the journey to be allowed.

The said Arnold, Cheney & Co. also agree to furnish the said Ernst R. Domansky, Jr. a free passage out and home, provide board and lodging and medical attendance and to pay all necessary traveling expenses while abroad.

And it is understood and agreed, that if on account of ill health, not arising from bad habits, the said Ernst R. Domansky, Jr. should under proper medical advice feel obliged to leave for home before the expiration of the three years above specified, his leaving under such circumstances would cancel this contract without penalty to him.
