I have noted your letter of June 9th, and as advised in the regular Agency letter, I expect to leave here for Zanzibar on the 21st inst.

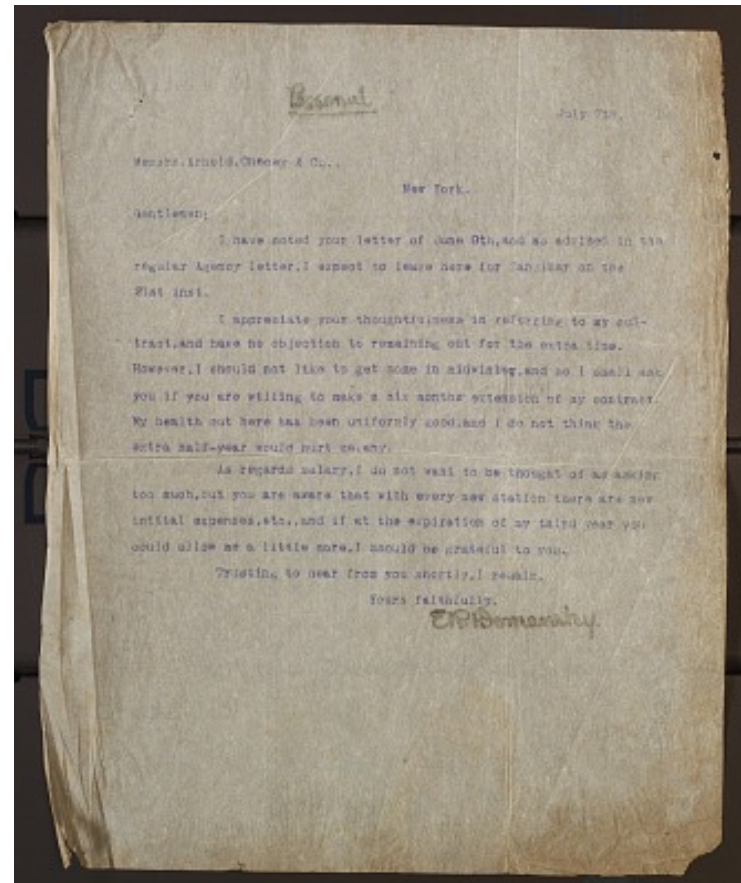
I appreciate your thoughtfulness in referring to my contract, and have no objection to remaining out for the extra time. However, I should not like to get home in midwinter, and so I shall ask you if you are willing to make a six months extension of my contract. My health out here has been uniformly good, and I do not think the extra half-year would hurt me any.

As regards salary, I do not want to be thought of as asking too much, but you are aware that with every new station there are new initial expenses, etc., and if at the expiration of my third year you could allow me a little more, I should be grateful to you.
