55,400.- U.S. Liberty Loan 4-1/4s

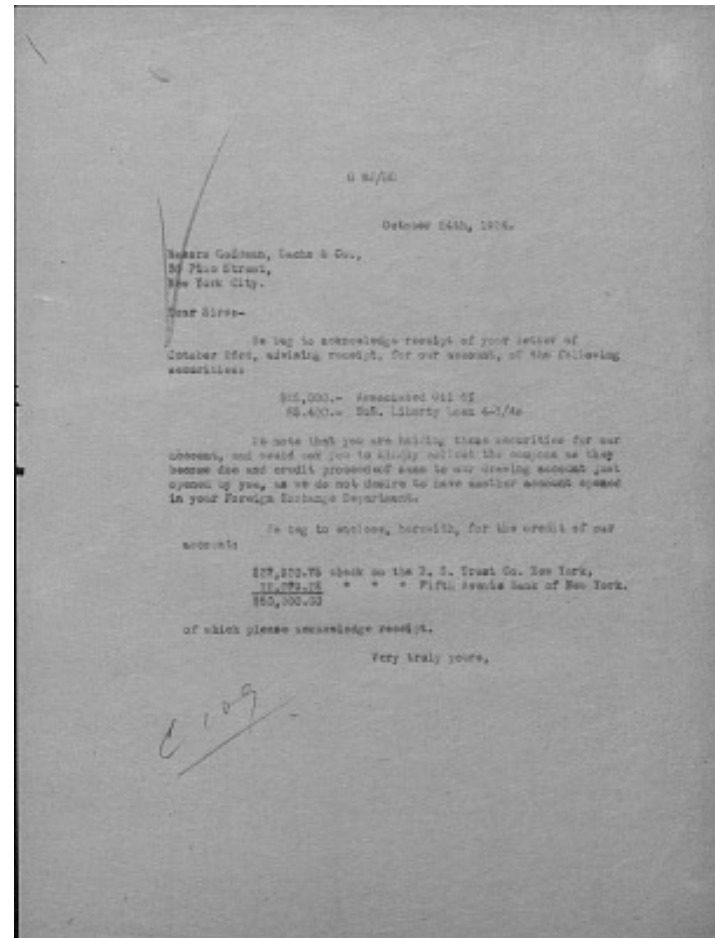
