The tract-book with all entries completed.

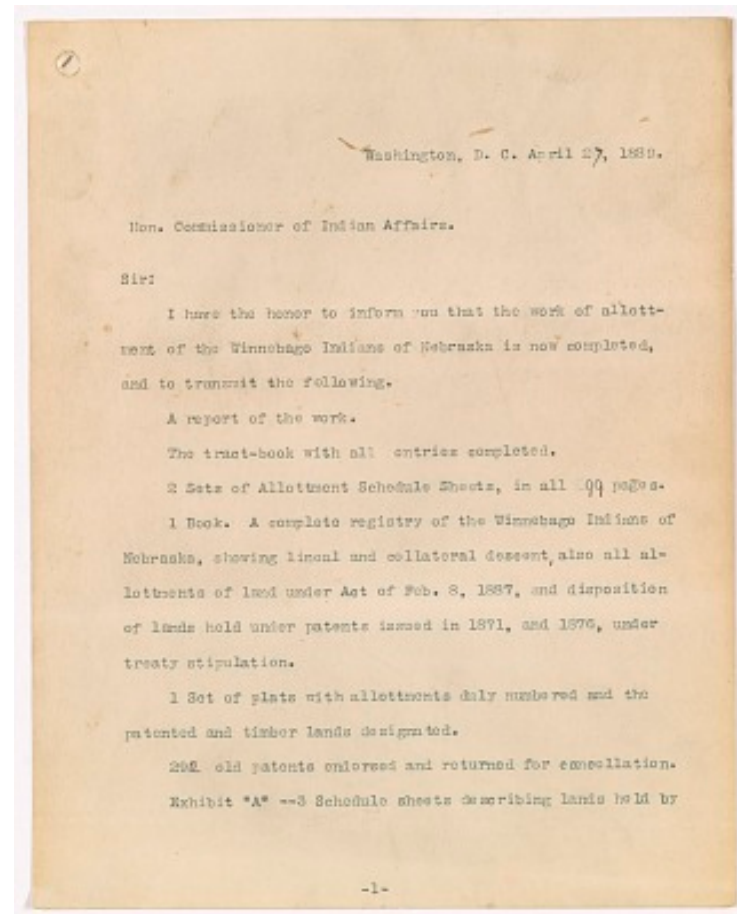
2 Sets of Allotment Schedule Sheets, in all 99 pages.
