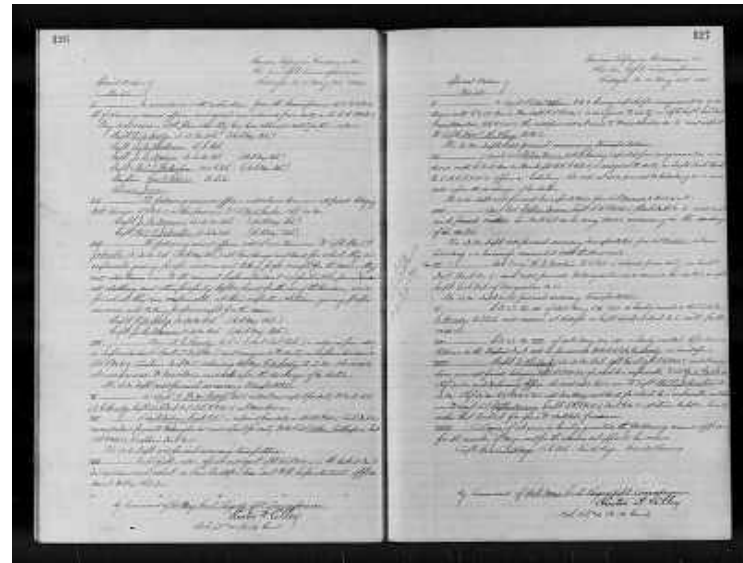

VII. Capt. D. H. Lentz, A.Q.M. Vols. Asst. Fincl. Agt. B.R.F. & A.L. will at once turn over all funds belonging to the B.R.F. & A.L. for which he is responsible, to Col. M. C. Garber, Chf. Qr. Mr. and Disbursing Officer. He will also turnover to Capt. Thos. P. Johnston, A.Q.M. Chf. Qr. Mr. B.R.F. & A.L. all buildings and lands for which he is responsible, and turn over to Lieut. Col. Stephen Moore, Supt. B.R.F. & A.L. Dist. W. N.C. all stores kept on hand within that District for issue to destitute freedmen.
