

Madam,

Major Vanderlip is absent, and will not return before April 1st.

I enclose teachers book bills as you request and think they all understand that these bills are to be deducted from their salaries. I will write to the Supt. about sending a teacher to Federalsburg, in place of Miss Iredell. He has lately visited that section and is better informed as to how large a school can be gathered there than I am.

The Superintendent at Richmond, Mr. Manly will give you information respecting schools in the country places of Virginia. There are quite a number of pupils in this city attending Normal Schools who are desirous of teaching in Maryland during vacation, and we hope you will be able to aid them. They will want to go to the field about the 1st of July.

All your new teachers have been instructed to report to you.

Is Miss Hall still at Chesapeake City? We can get no word from her.
