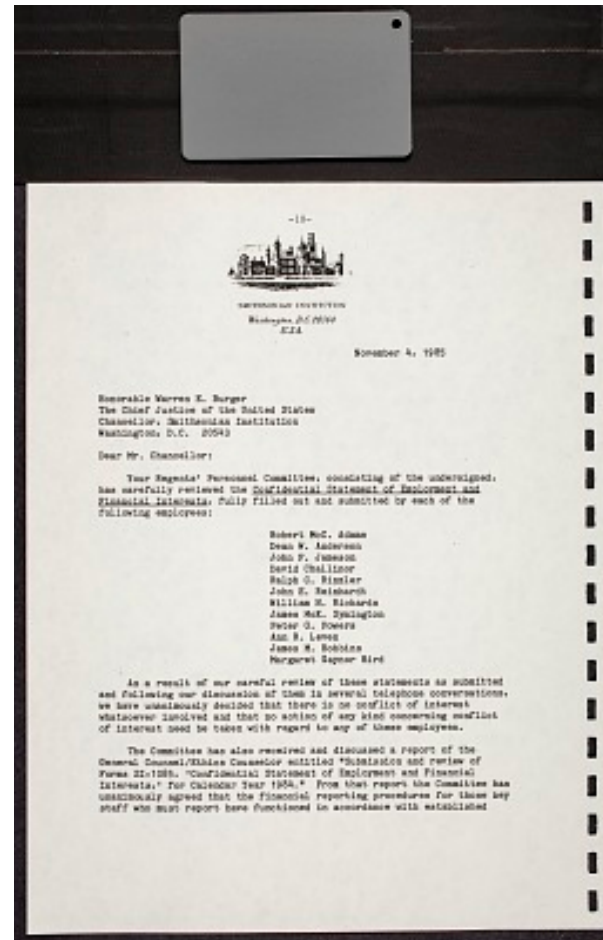
Dear Mr. Chancellor:
