
John Johnson has deservedly earned a reputation as one of the few New York reporters whom people call upon in times of need as evidenced when a gunman, holding a 15-year-old boy hostage in a Harlem church on St. Patrick's Day, 1977, summoned Johnson to the scene. After nearly two hours with the abductor, Johnson brought the situation to a peaceful conclusion by successfully disarming the gunman. For his critical role in resolving the event, which was exclusively captured on film for EYEWITNESS NEWS, Johnson was honored by a Civilian Commendation Bar and a Certificate of Commendation from the New York City Police Department and a City Council of New York Commendation.

Other distinguished EYEWITNESS NEWS investigative stories on Johnson's record include his December, 1979 report in which he took a hard look at crime in the New York City subways; behind-the-scenes special reports on New York City firefighters and policemen; and a special five-part April, 1978, EYEWITNESS NEWS series "King and Country," which examined the life and death of the late civil rights leader, Dr. Martin Luther King, Jr., and won top honors in the television news category from the Council of Churches of the City of New York in 1979.

AUBREY C. LEWIS, 44, former FBI agent and now Vice President for Security and Administrative Services, U.S. Woolworth-Woolco Division, F.W. Woolworth Co., joined the firm in 1967 as a Personnel Representative. He moved up the ladder to Assistant Corporate Vice President of Career Development in 1970 and in 1972 Administrative Services.

Lewis,a graduate of the University of Notre Dame in 1958 was an All American high school athlete in football and track. Lewis was the rushing and scoring leader and broke three state track meet records in a single day. In 1956, while at Notre Dame, he became national collegiate 440-yard hurdles champion. The first black to be elected captain of a team at Notre Dame Lewis established another world record in the 60 yard dash. Lewis was starting half-back on the football team for three years. (1955-6-7) being named to the All Mid-West and All American squad.

As an F.B.I agent in 1962, he trained in Washington, D.C. and Quantico, Va. and served in Cincinnati and New York for 5 1/2 years in criminal intelligence matters.
