Dear Mr. Porjes:

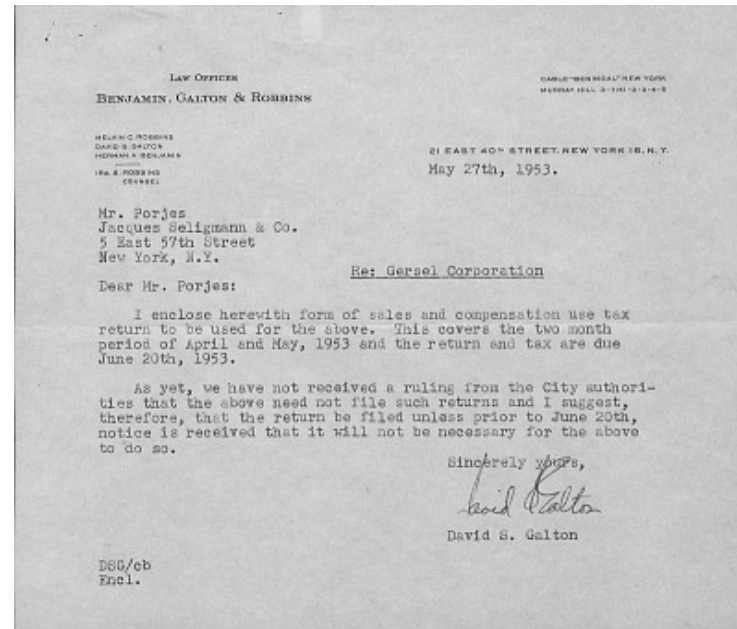
I enclose herewith form of sales and compensation use tax return to be used for the above. This covers the two month period of April and May, 1953 and the return and tax are due June 20th, 1953.
