If you could let me know whether these items were received by you I would be much obliged.

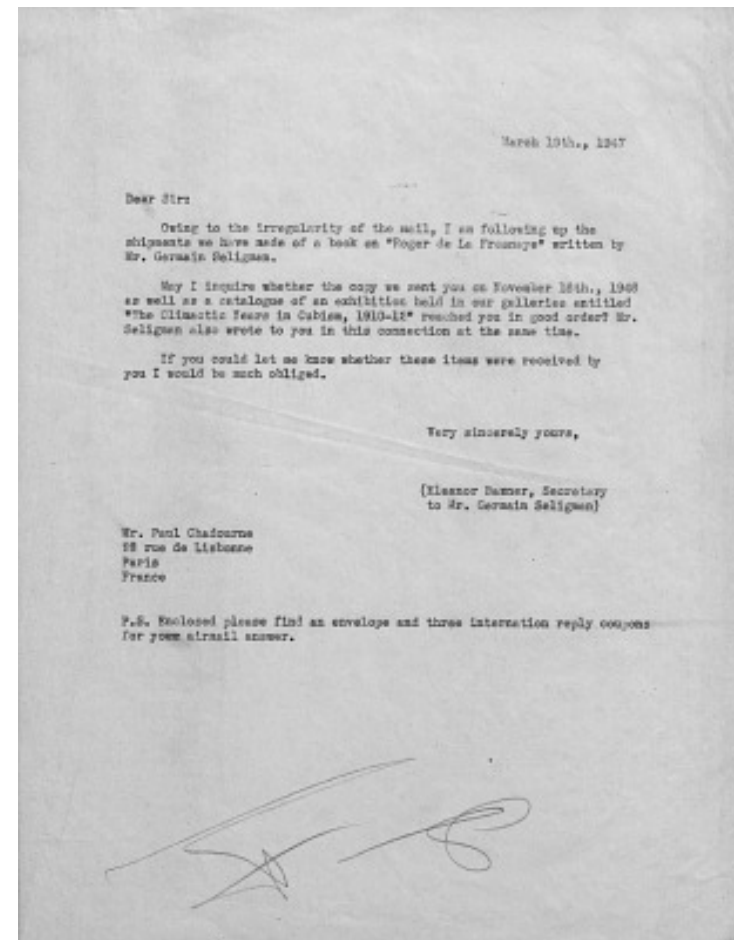
