In the meantime will you look over your various paintings and I will see you on Monday with a view of discussing the exhibit in detail.

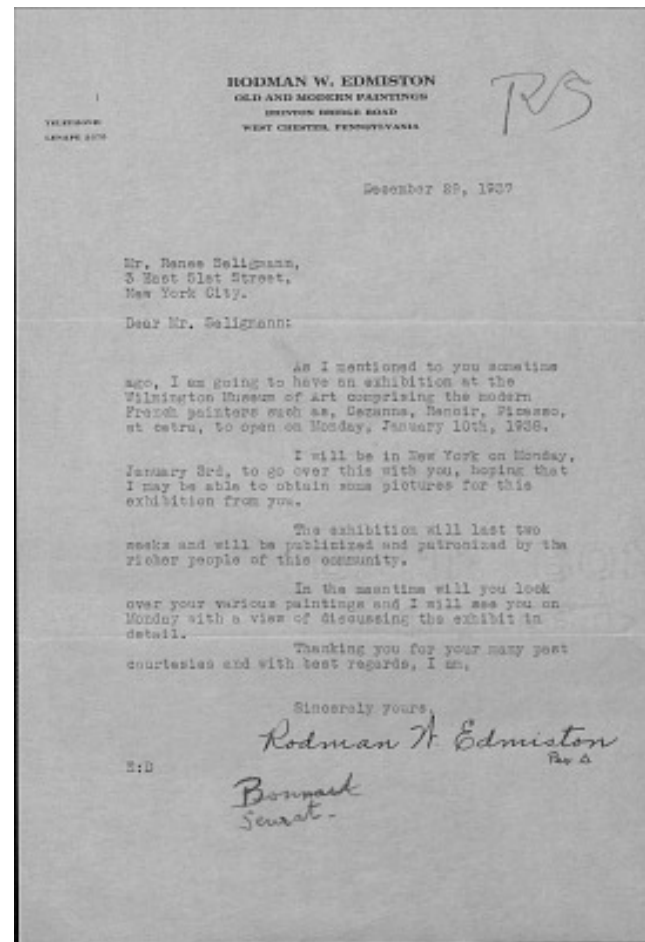
