Memorandum.

Questions by Judge Bond in behalf of Aid Societies.

Ques. Can you give buildings for schools?

Ans. Yes. As far as it can be done under the head of rentals and repairs and by the use of so called confederate property.

Ques. Can you give transportation?

Ans. Yes.

Ques. Can you give buildings for schools?

Ans. Yes, so far as it can be done under the head of rentals and repairs, and by the use of so called confederate property.

Ques. Can you give transportation?

Ans. Yes, by purchase only, with the exception of a few small boats, which are transported and be sent from Washington.

Practical method of getting rid of cost of transportation.

A teacher coming forward has received of transportation or have it provided, certified by either by the Bureau of Refugees, Freedmen, and Abandoned Lands, or by the War Department of Washington, or by the Civil War Commission.
