The Expenditures during the last month has been as follows

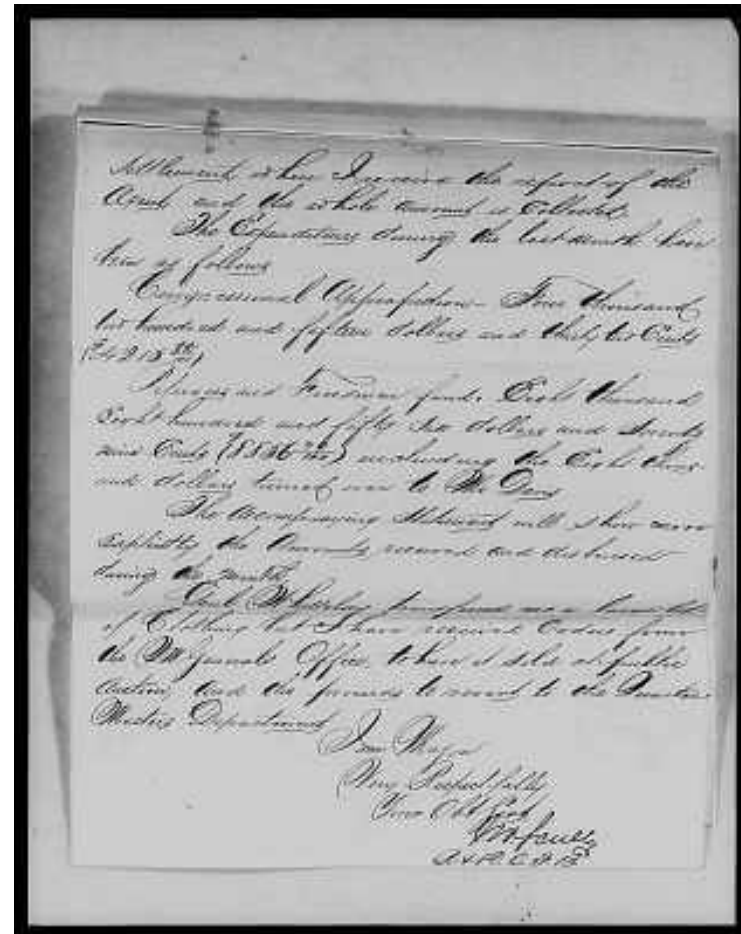
Congressional Appropriation — Four thousand two hundred and fifteen dollars and thirty two Cents (\$4215 32/100)

Refugees and Freedmen fund. Eight thousand Eight hundred and fifty six dollars and Seventy nine Cents (\$8856 79/100) including the Eight thousand dollars turned over to Mr Davis
