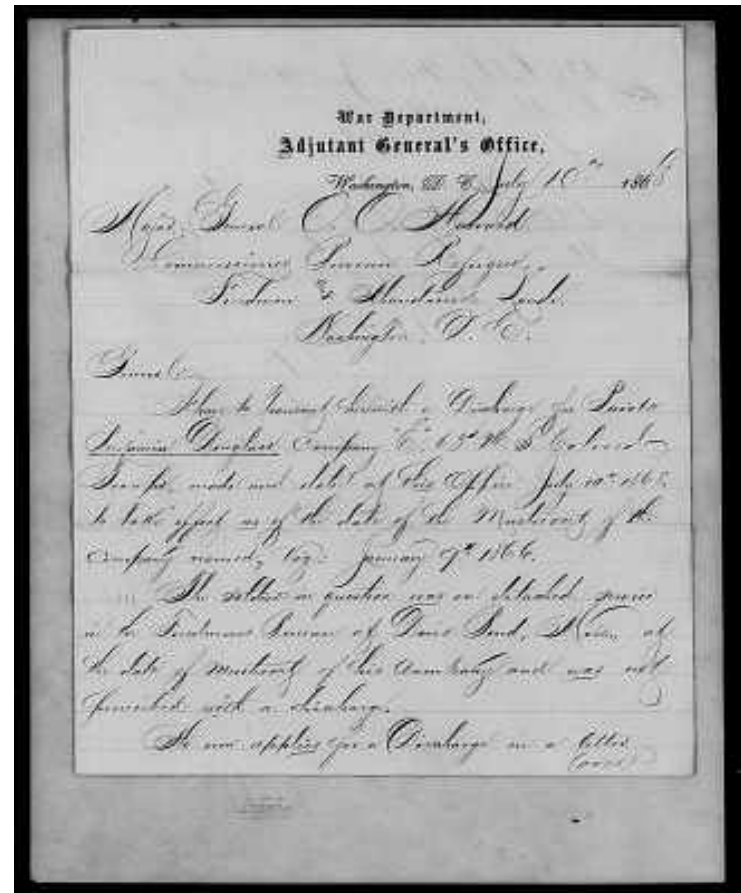

General:

I have to Transmit herewith a Discharge for Private Benjamin Douglass Company "E" 63rd U.S. Colored Troops, made and dated at this Office July 10th 1868, to take effect as of the date of the Muster out of the company named, Viz: January 9th 1866.

The soldier in question was on detached service in the Freedmans Bureau at Davis Bend, Miss., at the date of muster out of his company and was not furnished with a discharge.
