1, The purchases of stationery and property, made by Capt. J.W. Sunderland, V.R.C., Actg. Asst. Qr. Mr., B.R.L. & A.L., State of Miss., during the month of Sept., ultimo are hereby approved.

2, Officers and Agents of the B.R.L. & A.L., State of Miss., will without delay shift to Captain J.H. Chapman V.R.C., Actg. Commissary of Subsistence, Vicksburg Miss, all the corn and meat sent to their respective Stations for issue to destitutes, under late act of Congress, and now remaining in their possession, taking receipts therefor.

3, Capt. J.H. Chapman V.R.C., Act'g. Commissary of Subsistence Sub-District of Mississippi, will without delay inspect and report on the condition of twenty nine thousand four hundred and ninety four (29,494) lbs. of corn, for which Lieut. H.R. Williams, 45 U.S. Infy., Assistant Inspector General Bureau Refugee, Freedmen, and Abandoned Lands, is responsible, with a view to its final disposition.

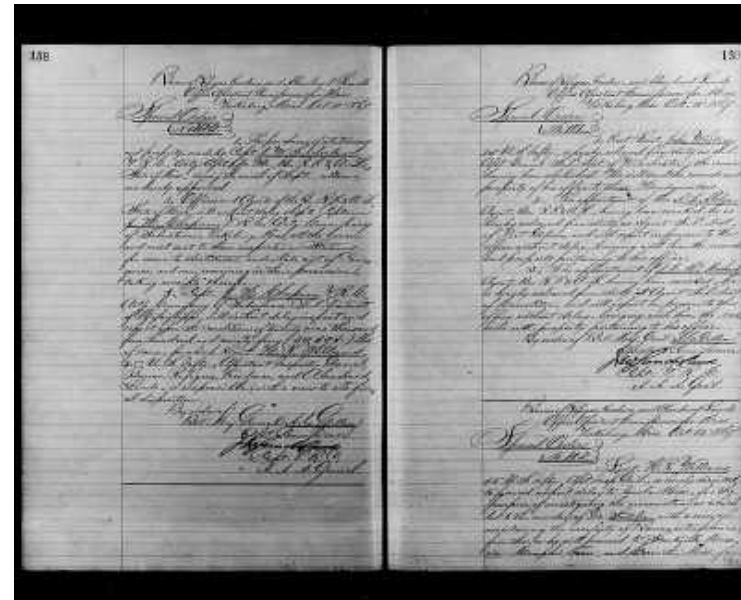
