To the Freedmans Bureau at Greensboro N.C.


The bearer hereof John is an applicant for provisions for himself & family.

I inherited his wife in 1833 and at his request got him in 1835 - he has a large family of children and grandchildren as well as great grandchildren he became afflicted with pain about the year 1855 and I supported him until the end of 1865. since then he is going about among his children and they are scatered in Yadkin County in Rockingham & Forsyth & Colby Counties he is an object of charity and no provisions for the poor has ever come to Stokes County to my knowledge Mr W Gentry is the Freedmans Bureau in Stokes and lives within two miles of me he tells me he has had none. I believe his family ought to have provisions as much so as any.

According to the bill of sale I have he is seventy five years old I refer you to JP Morehead John A. Gilmer} Robt. A Dick} JB McLane} Robt Sloan} James Sloan}
