2.3.5. FLIGHT CAPTAINS

Basic Function:

To accomplish the operation and navigation of a helicopter on an assigned flight in a safe, efficient, skillful manner and in accordance with the rating limitations set forth in his pilot certificate. To operate a helicopter in accordance with the provisions of New York Airways' Air Carrier Operating Certificate. To operate a helicopter in accordance with the flight and operating limitations approved by the Civil Aeronautics Administration.

Responsibilities:

- 1. Conduct their activities in accordance with Company rules and
- 2. To maintain his Flight Operations Manual up-to-date at all times.
- 3. To acquire and maintain all licenses and ratings as required by Company standards.
- 4. To cooperate with other Departments of the Company in order to insure a safe, dependable, and economic operation.
- 5. To check and ascertain that the condition of helicopters and the fuel and load complement meet all requirements.
- 6. To report promptly to the Dispatch Office if sickness or other difficulties prevent reporting for duty on time.
- 7. To execute such routine or special assignment as may be delegated by the Chief Pilot.

Basic Relationships:

- 1. The Pilot personnel are administratively responsible to the Chief Pilot for the discharge of all responsibilities delegated.
- 2. Pilots are responsible for the supervision of the activities of Pilot
- 3. All Pilot personnel are expected to cooperate fully with other organizational elements toward the achievement of a well intergrated [[integrated]] operations organizations.

Basic Function:

To Assist the Flight Captain in carrying out his duties and responsibilities in order to accomplish the operation and navigation of a helicopter on an assigned flight in a safe, efficient and skillful manner, in accordance with the rating limitations set forth in his pilot certifications.

- 1. To maintain his Flight Operations Manual up-to-date at all times.
