Dear Mr. Tannahill,

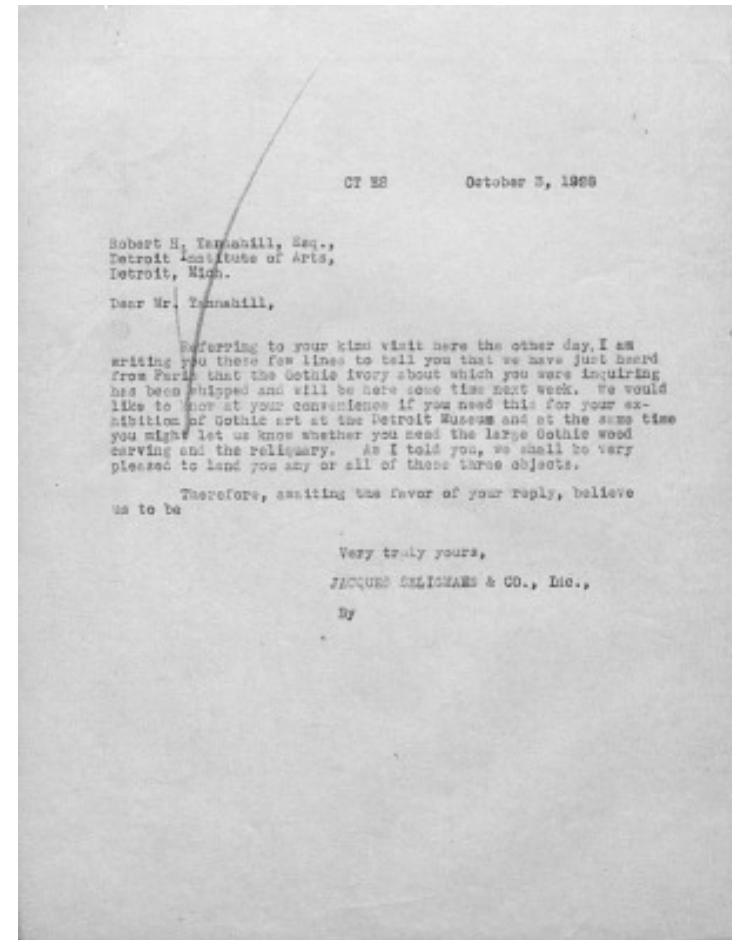
