| April 23<sup>rd</sup>/68 | Sweet Owen Jay 2nd Lieut 40<sup>th</sup> Infy & U.S.A.C. | April 20<sup>th</sup> 1868 States that Wright Pickett Freedman complains that one John Jones White living in Onslow County, unjustly whipped a colored boy names Charles and a colored woman named Ollay, happened on the night of Mar 30<sup>th</sup> 1868, also that Wright can produce 4 witnesses in the case. Refers the cases to Capt Curren as they are not in his Sub district |
