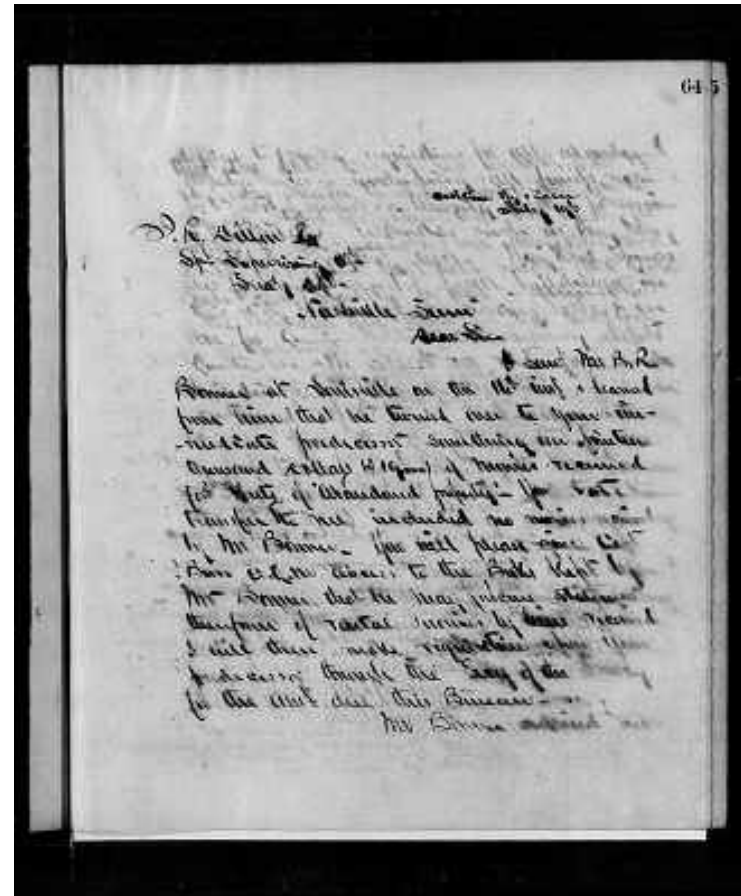

Dear Sir.

I saw Mr. B. R. Bonner at Louisville on this 16th inst. & learned from him that he turned over to your immediate predecessor something over Nineteen thousand Dollars (\$19,000) of monies received for duty of "Abandoned property" - Your late transfer to me included no monies receipt by Mr Bonner. You will please give Capt Burr A.Q.M. access to the Books kept by Mr. Bonner that he may procure statements therefrom of rental monies by him received. I will then make requisition upon your predecessor through the Secy of the County for the amt due this Bureau.
