I, L A Galloway, a resident of Brunswick County, North Carolina, am personally acquainted with Becky [[Eves?]] widow with 4 children destitute, who reside Brunswick County, North Carolina, and state, to the best of my knowledge and belief, that she is unable to maintain herself & children and has no friends to assist her and is worthy of charity from the government, and is in danger of starvation if relief is not given given.
