I am taking the liberty of notifying NCAI members who are on the program so that there will be a minimum of confusion during the Convention

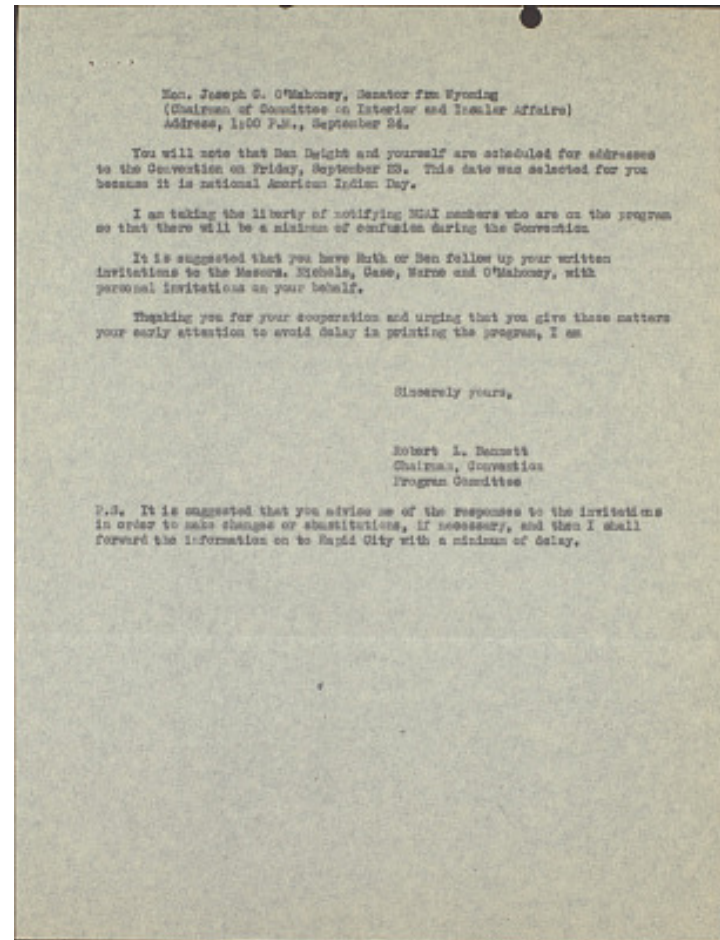
