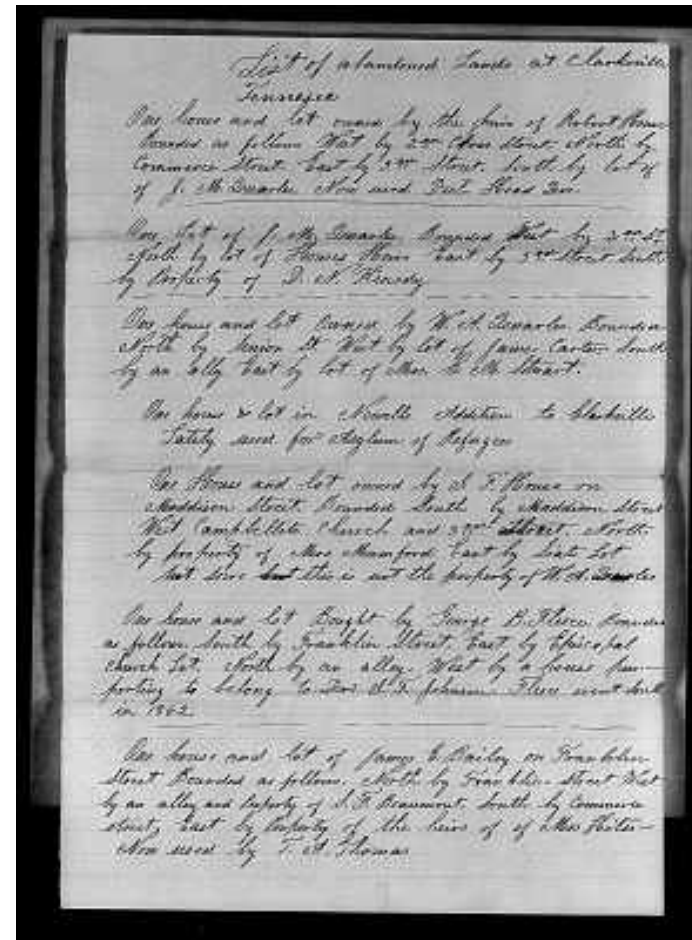

One house & lot in Newells Addition to Clarkville. Lately used for Asylum of Refugees

One House and lot owned by J. F. House on Maddison Street. Bounded South by Maddison Street West Campbellite Church and 3rd Street. North by property of Mrs Mumford East by Siats Lot Not sure ~~but~~ this is not the property of W. A. Quarles

One house and lot Bought by George B. Fleece. Bounded as follows. South by Franklin Street. East by Episcopal Church Lot. North by an alley. West by a house purporting to belong to Dr. J. F. Johnson. Fleece went South in 1862.
