Col Benham will see that this Camp and Farm pays for its stores received from the Commissary Department unless it has been otherwise ordered by the Secretary of War. 
Little Rock. Ark. March 14th 1865.

The issues of Subst. Stores to freedmen at the "Home Farm" & Camp at Little Rock, were made under Special Orders No. 63, Vicksburg Miss, Sept. 29th 1863, "by Order of Secretary of War", signed "L. Thomas, Adjt. Genl."

The negroes were mostly women & children, all "destitute", & some sick & unable to perform labor-
