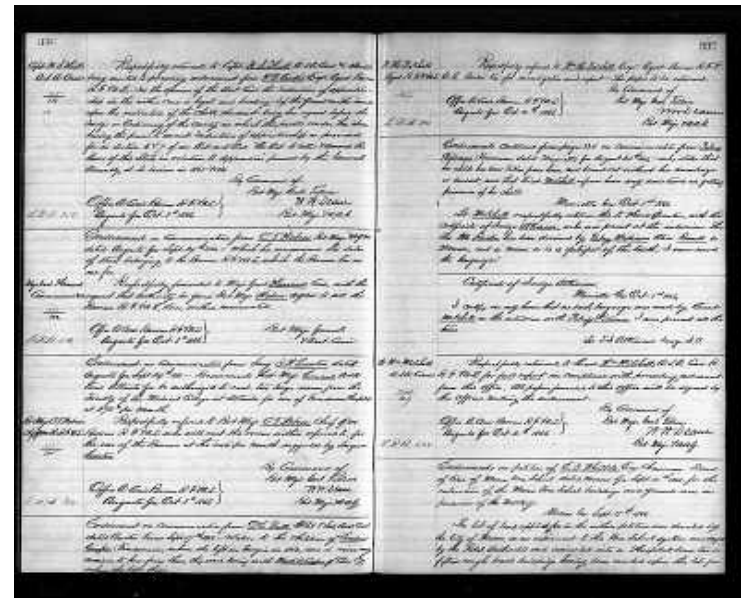

Lt Mitchell respectfully returns this to Head Quarters, with the certificate of Judge Atkinson, who was present at the interview. The Rev Mr Rucker has been deceived by Patsy Williams Alias Russell a Woman, not a man, or is a falsifier of the truth, I never used the language!
