It appears upon investigation that a woman and three children was supported by Rogers during the time Newton Ware and Cyrus Strickland was in his employment, that this woman is the mother of Newton Ware, and an Aunt of Cyrus Strickland, that the said Newton & Cyrus agreed to labor for Rogers at \$18.00 per month and pay for provisions furnished in support of this woman and children out of their wages. Enclosed a/c's sworn to by Rogers if allowed bring Newton \$27.25 in debt, and Cyrus \$6.45 in debt.  
Rogers utterly denies using any violence in forcing either of the freedmen from his employment.
