Thirty bushels of potatoes [[strikethrough]] at [[/strikethrough]] Thirty bushells of peas, and two thousand pounds of Fodder. all I was allowed from Mr Jackson after being drove off was \$120 for my share of the crop. I also worked for Mr Jackson last year as a carpenter and for which he owes me \$20.50.
