June 28th 91 \* | Brower Jacob W. President Filed | Hamburg, N.C. June 15th 67 Requests appointment of Jno. M. Marshal, Bureau Agent for Surry Co.

June 24th 92  $^{\star}$  | Bolenius A. W. Sub. Asst Com Filed | Greensboro, N.C. June 24th 67 States that he has employed Mr. R. E. Potts as clerk at a salary of \$100.

June 28th 93 \* | Bolenius A. W. Sub. Asst Com. Filed | Greensboro, N.C. June 26th 67 Makes requisition for consolidated Ration Return blanks

July 5th 97 \* | Boyd D. A. Filed | Swifts Island, N.C. May 1867 Requests the U.S. authorities to send supplies to the suffering poor in Montgomery Co.

July 8th 98 | Blood Carrie E. Trans approved July 8th 67 | Raleigh N.C. July 6th 67 States that transportation has been furnished her only to Worcester that her home is in Lynn N.H. requests that transportation be furnished from Worcester NC to Lynn, N.H.

1867 July 8th 99 | Bolenius A. W. Sub Asst Com'r E.M. 270 | Greensboro N.C. July 2nd 67 Submits letter from certain parties in vindication of his estimate of rations forwarded sometime since and which was considered to excessive by the Asst. Commissioner.

July 8th 100 | Bolenius A. W. Sub Asst Com'r E.M. 270 | Greensboro N.C. July 3rd 67 Forwards Ration return for approval and requests stores be sent from Raleigh as the Post Commissary will not issue to him.



July 8th 101 | Bentzoni C. C. Bvt. Lt. Col. Comd'g Post July 8th 67 Forw'd to 2nd Mil Dist. Hd Qrs approved. | Plymouth, N.C. July 5th 67 Requests the within named men may be substituted for those already detailed by S.O. from Dist. Head Qrs. as the latter are noncom officers.

July 9th 102 \* | Ballock Geo. W. Brig. Gen. Chf. D.O. Filed | Washington, D.C. July 5th 67 Acknowledges receipt of June 2 Report of Persons and articles hired

July 16th 103 | Bolenius A. W. Maj. Sub Asst Com'r July 16th 67 Referred to Dr. H. C. Vogell If this man canbe found he must make provisions for his family E.M. 295 | Greensboro, N.C. July 15th 67 Asks that Geo. Barringer a teamster for Government now in Raleigh be looked up and made to support his wife and children who are applying to him for rations.

July 16th 104 \* | Beckwith Allen July 16th 67 Forw'd Gen. Howard, recommended that the boy be returned to his father. Rec'd back Aug. 5, 67 Filed. Letter Book 48 | Smithville, N.C. July 10th 67 Requests that the Gov't return him his son Isaac, now living in Mechanicsville near Charlotte Hall Maryland, as he was taken away by the Army when it passed.

July 17th 105 | Bolenius A. W. Maj. Sub. Asst Com'r July 17th 67 Ret'd The facilities of the D.&.D. Inst. are not adequate for admittance of additional pupils at the present time | Greensboro, N.C. July 9th 67 States that a white man Frank Pearce seduced by force a deaf and dumb colored girl and that she is now with child.
