November 1st\* | ^1 Cunningham J.H. |[[Woodsdale?]] N.C. Oct. 25 "66. States that his mother owned a family of colored people, and that three of the children are hired to her for the present year: that both Father and Mother of the children, claim them and the wages that may become due them. Requests information, as to which of them Father or Mother, is entitled to the children and to receive their wages.

November 3\* | ^2 Coats James (clerk) [[L.?]] B.200 | Janes City N.C. Oct. 29" 1866. Respectfully requests that his salary be increased to One hundred dollars per month.

November 12\* | ^3 Coats Andrew Lieut and Asst.Supt. Trans. furnished | New Bern Nov. 9" 1866. Makes application for transportation for Julia Foy destitute freedwoman from New Bern N.C. to Magnolia Duplin County N.C.

November 16\* | ^4 Coats Andrew Lieut and Asst. Supt. | New Bern N.C. Nov. 14" 66. Acknowledges receipt of transportation order No. 99.

November 28" | ^5 Cook B.C. Bvt. Capt. E.B.p. 56. | Richmond Va. Oct 15" 1866. Writes in behalf of Susan Clary (col'd) who wishes to obtain her grandson, an orphan boy, 6 years old, named Harrison and at present living with [[Evereth?]] Shipp of Concord Cabarrus Co. N.C.


November 29"\* | ^6 Coats Andrew Lieut.| New Bern N.C. Nov. 26" 1866. Acknowledges receipt of discharge papers [[Thm.?]] Reed.

December 5" | ^7 Cogswell M: Bvt. Col. E.B.p. 61. | Raleigh N.C. Dec. 4" 1866. Requests that a Private of 8th Infantry be detailed to report at his office as permanent orderly and to take charge of the office.

December 6"\* | ^8 Cogswell M. Bvt. Col. | Raleigh N.C. Dec. 4" 1866. Acknowledges receipt of transportation order No. 107.

December 6"\* | ^9 Coats Andrew Lieut | Trans fur. | New Bern N.C. Nov 26" 1866 Makes application for transportation for freedmen

December 8" | ^10 Clous J. W. Capt and A.A.A.G. EB p.[[64?]] | Charleston S.C. Nov. 23" 1866 Directs that Priv Frank Cole, a deserter of Co. F.6" U.S. Infantry be forwarded under a suitable guard to Cmdg. officer. Post of Charleston.

December 14" | ^11 Cook George [[P.?]] [[Editer?]]. E.B. p. 76. | Hillsboro N.C. Dec. 3" 1866. Reports that a colored boy was tried for larceny at Greensboro N.C. and sentenced to be hung: that there is great excitement in that section amongst the colored people, about the injustice of the decision and sentence of the court.

December 14"\* | ^12 Curren J.F. Lieut | Smithfield N.C. Dec. 8" 1866. Reports the action of the county court in [[binding?]] out a freed boy, who was previously engaged under contract, approved by an officer of the Bureau: also copy of contract.

December 17"\* | ^13 Carr E.H. Bvt. Maj. Gen'l. | Raleigh N.C. Dec. 14" 1866. Declines detailing an enlisted man for duty at Head Qrs Col. Cogswell Act'g Supt. Bureau.

December 19" | ^14 Clay [[P.?]] E.B. p. 76. | Salisbury N.C. Dec. 14" 1866. Applies for transportation for 33 men, 17 women, and three children between four and eleven years of age, from Salisbury N.C. to Brenham Texas, whom he has employed to labor in Texas.

December 20" | ^15 Cherry W.M. Late Lt. [[1st?]] N.C. Vols E.B.p 73. | Washington N.C. Dec 4" 1866. States that Joseph Wiggins, 12 years old is held by one Reddick Carney. The father of the boy has applied to the office of the Freedmens Bureau, but the officer thus far has been unable to procure the release of the boy.

December 20"\* | ^16 Coats. A. Lieut Trans. furnished | New Bern N.C. Dec. 11" 1866. Makes application for transportation for freedman from New Bern N.C. to Wilmington N.C.

December 20"\* | ^17 Coats A. Lieut.
Trans. furnished | New Bern N.C. Dec. 14" 1866. Makes application for transportation for freedman from New Bern N.C. to Warsaw Duplin Co. N.C.
