November 3" ^[[asterisk stamp]] | ^1 Doherty Robert (clerk.) L. B. 200 | New Bern N. C. Oct. 26" 1866. Requests an increase of Salary to one hundred dollars per month.

November 3" | ^2 Dilworth A. Agent. E. B. p. 32. | Greensboro N. C. Oct. 23^d. Asks if Rankin [[Wagner? Hagner?]] (freedman) who served in the army as Cook from the occupation of Wilmington until May 15" 66 can get any pay.

November 3" | ^3 Dillon Richard Capt. E. B. p. 32. | Beaufort N. C. Oct. 20" 1866. Respectfully informs Capt. Jacob. F. Chur A. A. A. G. thro. Lieut Col. S. Moore Supt. that the boat has not been disposed of yet, and shows the necessity of a boat being required in his Sub. District.
