The War Relief Clearing House for France and Her Allies, after full consideration of the difficulties in transportation, distribution, etc., due to the existing military situation is persuaded that the arrangements made are most desirable and will result in greatly increased efficiency of operation.

In view of the uncertainties of transportation and the grave submarine danger, it is most strongly urged that contributions for France be made in the form of cash with which to purchase articles in France wherever possible, rather than in the form of supplies, [begin printed underscore] except as information with regard to existing needs in France shall be from time to time furnished by the Red Cross [/end printed underscore].
