My Old,

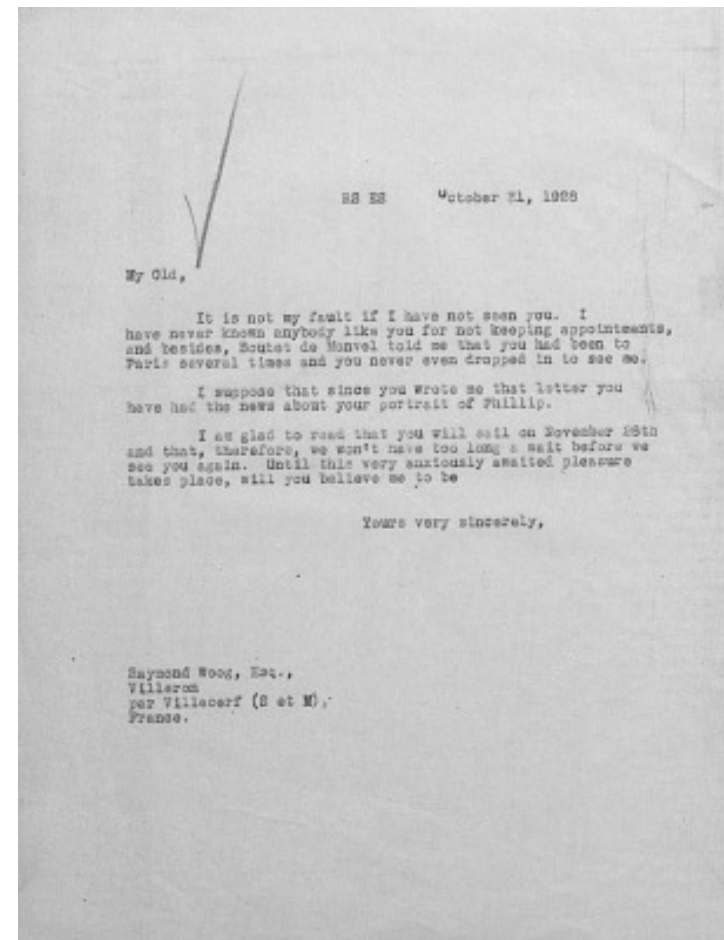
