However, I find the price a bit high for a second line artist.

Would you be good enough to let me know at what best price I could acquire it, including your commission.

Would you have the painting go to you first, and then to me; or would it go to me directly from Meissner? - If so, would you be kind enough to explain to him that it should be shipped by air, and addressed as follows:

Also, that the original of the invoice and of the ^[[customs]] documents should be mailed to us, and a copy of each one of them to BEMO.

Do let me know whether it has a frame.

You mention that it came from the GRIMALDI Collection. What is the latter, and in what country or city was it?


