I thank you for your letter of the 14th November. You are right in saying that the picture which I may be able to offer now is much more expensive than the one which I had during the summer. But as I told you the owner is a different person, with a different idea of prices, but I must also add that the subject of the present picture is much more attractive, representing attractive females as opposed to dull males.

The [[underline]] two [[/underline]] large paintings are in Washington (plate 2 and 3); plates 4 and 5 are still with the Merton family; plate 7 is in the Museum in Hull; plates 8 and 9 I sold and the painting reproduced under plate 10 is the one now under discussion, i.e. the only one still possibly available.

Of the two which I sold, No. 9 I sold to a private collector, what happened to No.8 which, as you know I sold to a dealer, I do not know.

I have not seen the painting recently, but when I saw it at the sale at [[strikethrough]] Christies [[/strikethrough]] ^[[Sothebys]] it was very dirty but seemed to be in very good condition. I am quite sure that cleaning and restoring would not be any problem here in London and I would gladly supervise such an undertaking.

I saw in the Burlington Magazine that you are holding an exhibition of Master Drawings. In case there is a catalogue I should be very grateful if you could spare me a copy.
